As outlined in the proposal, a **Working Group (Voting Procedure Modifications)** was formed.

The Working Group tasks are:

1. Provide recommended modifications to the present ICCF Voting Regulations and Electoral Procedures and any suggested changes to the ICCF statutes.
2. Creation, approval, and distribution of a communications plan to explain and educate delegates on (whatever) the new voting process becomes. Please include in the communication plan options for testing to ensure all delegates understand the new process, and additional personnel (specify any additional costs) to review, remind, and correct any delegates that are not following whatever the new process might be. Please specify additional requirements as well that Congress will need to develop to "encourage" delegates and other voting members to adhere to any new processes and procedures approved by Congress. Please include in the communications plan the impact to ICCF when: proposals may be submitted at any time, including at Congress, no analysis is completed in advance of Congress, proposals are considered and voted on by well-to-do or subsidized delegates attending Congress, deliberations are limited and restricted by the time in Congress, votes are called immediately, and a rough count of hands suffices for recording Congress intent.

3. Consider in the communications plan a change of Congress conduct to allow extra time to patiently explain to all voting members that arrive unprepared and uninformed all the nuisances of each proposal prior to discussion and voting, to include the intent, purpose, benefit, rationale, assessment, effort involved, cost estimates, considerations, and documentation affected. This might mean extending Congress again an extra day or two to accommodate those who arrived unprepared or uninformed (i.e., holiday) and/or extending Congress to start earlier in the morning and/or end later in the evening. Please review and suggest adjustments to the Financial Plan and Congress documents to account for unexpected delays to accommodate unprepared delegates or appointed voting members. For any additional costs incurred by Congress, please include recommendations for raising revenues to offset the increased expenses, such as, raising tournament entry fees, for example.
4. Develop webserver process, requirements, specifications, and testing schemes to be reviewed and costed by our webserver developer contractor. Coordinate and monitor implementation testing on the Test server and report results.
5. Pending completion, recommendations, testing, and implementation of Working Group tasks 1 through 4 as outlined above and as voted on in Proposal 2017-018, ICCF will immediately discontinue use and maintenance of the online voting module and revert to ICCF statutes for guidance on voting, i.e., "Proposals relating to the agenda of the Congress must be received by the General Secretary, or the appropriate ICCF official, at least one month prior to the commencement of the Congress." Additionally, voting at Congress in 2018 (if there is a Congress) will follow the statute guidance, "ICCF Members have the right to participate and vote at the Congress, or to appoint a proxy in writing to vote on their behalf, ..." The single deadline(s) for a 2018 Congress (if any) are will be as articulated in the ICCF Statutes, "Proposals must be submitted no later than one month before Congress."

Official's Reports- Errata

Zones

Elections for Zonal Director need to be held for Zone 1 and the World Zone. There was some discussion and interesting suggestions about the name of this new zone, mostly focused around the applicability of the word "World" to a zone. However, several general definitions of a zone challenge the very use of the word zone to define a group of Federations with (seemingly) nothing in common:

(a) any continuous area that differs in some respect, or is distinguished for some purpose, from adjoining areas, or within which certain distinctive circumstances exist or are established.

(b) *Geography* - any of five great divisions of the earth's surface, bounded by lines parallel to the equator and named according to the prevailing temperature.

Perhaps the only definition that might be applicable would be the verb *zone*, "to divide into zones, tracts, areas, etc., as according to existing characteristics or as distinguished for some purpose."; however, the *purpose* seems to be elusive. The future ZD of the new zone will tackle this conundrum of nomenclature and perhaps, arguably, raises the question of the need for zones as the interest in postal play continues to diminish and the prevalence of the webserver eliminates any geographic considerations.

Ratings

All professional and academic names have been removed from the database. Ongoing discussions and analysis regarding the Glickman rating system will continue.

Finances

Congress participants voted unanimously to approve the financial report and various statements and plans. Two questions were raised regarding the presentation of the financial plan. Cell C39 (Cash Prize Estimate for 2017) - why did the figure go down from previous years? The response was that figure is heavily weighted to the DE Webserver tournament, which is held every 5-years. Another question was why cell J16 (Web Chess Open Revenue estimate for 2019) was so low? **[Does anybody remember?]**

Proposal 023 was linked to the Financial Report, Appendix D. The Finance Director reported approval of the proposal would cost ICCF approximately 2.000 Euros per year (negative cash flow). A discussion ensued about our cash position and various explanations of what affected cash and what did not (e.g., depreciation). Congress requested that the Finance Director consider creating a Statement of Cash Flow to accompany the other financial statements prepared.

Auditor - concerns about VAT that surfaced in the 2016 Congress are still present. ICCF President responded with a prepared [PowerPoint presentation](#) addressing the issues.

Tournaments

NTTC - a concern rose (and has been raised in previous years) that the title “Non-Title Tournament Commissioner” is seen as both (a) negative and (b) not truly reflective of the position as many tournaments under the authority of the NTTC do grant titles. Open for consideration is another (better) name for this commissioner. Delegates are requested to forward nominations to the EB (via the GS) and/or submit proposals for the next Congress.

A reminder that the Non-Title Tournament Commissioner (NTTC) is responsible for non-title tournaments to include the World Cup, Veterans, World Cup, and Champions League, to name a few. All requests to serve as Central Tournament Organizer for future tournaments should go through and be approved by the NTTC.

Promotional Tournaments - Jörg Kracht (GER) has assumed responsibility for these tournaments from Olli Ylönen (FIN).

ICCF World Cup 22 - the NTTC has announced that The Netherlands has been selected as the Central Tournament Organiser for this tournament.

2018 Congress

As of the 2017 Congress, there were no bids for host the 2018 Congress. According to the statutes, the ICCF President will decide. His choices include: (a) reopening the bidding period, (b) hosting a presidium or modified EB meeting, or (c) nothing.

The President has decided to reopen the bidding to host the 2018. Federations wishing to host the 2018 Congress must submit full proposals to the President and General Secretary no later than December 31, 2017. A decision will be made shortly thereafter. (Note: If a 2018 Congress host is selected, Zone 1 has pledged 2.000 Euros towards support of the Congress).

Because Congress voted to reverse the provisions of Proposal 2016-012 (<https://www.iccf.com/Proposal.aspx?id=36> Delegates Not Able to Attend Congress) with approval of Proposal 2017-018 (Use of the Online Voting System Should Not be Compulsory), The EB and especially the Services Directors committee are awaiting detailed requirements and specifications for a replacement voting schema.

2019 Congress

A reminder that this will be an election year (EB + Auditor). Notices of intent to host are being accepted by the EB and voting will take place for all valid proposals at the 2018 Congress (if there is one). Thus far, expressions of interest to host Congress for: (a) 2018 - Wales, England, and South Africa; (b) 2019 - none; (and (c) 2020 - USA.
